2023 will be remembered as the summer of returning to normal in the golf industry and all of its activities. Golf courses throughout Manitoba and North West Ontario saw record numbers of rounds this year, including the highest number of scores posted to the Golf Canada Score centre in a number of years. Clubs were once again able to host charity golf tournaments, weddings, and other functions that helped their bottom line.

Our 2023 tournament season was a success this year with a continued increase in participation. These events took place around the province thanks to the generosity of our member clubs in allowing us to utilize their great facilities. Once again, it was one of the few years where no tournament days were lost to rain!

The First Tee program kicked off in our region this summer through the generosity of a new Sponsor for our prairie region. We expect to see continued growth with this program in 2024, now that we have the first year under our belt.

We are thankful to have our team at Golf Manitoba, including our Executive

Director, Jared Ladobruk, and his exceptional team of Amy Coggan, David Borowski, Brian Munz, Emilee Melnyk and Nate Hunter. The Provincial championships we organize and host serve as one of the core functions of Golf Manitoba. I would like to thank and congratulate all golfers who participate in these championship events.

Our junior development programs continue to thrive and grow, thanks in a large part to our coaches Bri-ann Tokariwski and Sean Murray. We now have a new indoor practice facility in the Sport Manitoba Building that will allow our junior teams to continue their development in house during the winter months.

A huge thank you to our volunteers! They are the backbone of Golf Manitoba. These individuals work tirelessly for the Association, giving back to the game. Our referees, course raters, on course volunteers and tournament support teams provide our team the assistance required to deliver great service.

Thank you to our corporate sponsors who graciously continue to support our sport.

A thank you to my fellow board members for their service this past year and a special thanks to Ken Warwick and Jim Gosman who are at the end of their 10-year term on the Board

## REPORT OF THE EXECUTIVE DIRECTOR

I am pleased to report that 2023 was an exceptional year for Golf Manitoba and our golf stakeholders.

This year we welcomed a new partner in grassroots sport development, saw a dramatic increase in score posting, participation in our championships grew, and our membership exceeded 10,000 for the first time in 10 years. These outcomes would not have been possible without the concerted efforts of our volunteers, membership, board and staff, and our corporate and sport partners.

In the spring, the First Tee - Prairies was launched with the help of a chapter founding gift by the Aune Family. The generosity of the Aune family will fund and facilitate the First Tee - Prairies in communities across Saskatchewan and Manitoba, introducing golf and the positive experiences associated with golf to youth across the provinces. First Tee provides accessible and inclusive youth development programming at golf courses, schools, and community centres creating community participation pathways, especially for youth who may have otherwise not had the opportunity. We are proud to be a partner of the First Tee - Prairies and look forward to all we can accomplish in the years to come.

From a score posting perspective, it was encouraging to see the activity of our member golfers. Golf Manitoba members posted 283,152 rounds as of the writing of this report. That represents a 28% increase over 2022. Nationally, Golf Canada is on pace to shatter a new record of over 10 million rounds posted.

In March we welcomed David Borowski to our team as our Director of Competitions & Rules. David has over 20 years of industry experience and it showed. He did an impeccable job with our events and is well on his way to setting up another great year of competition in 2024. Welcome to the team, David!

Financial performance remains a priority and the Board and management are encouraged with the operating results outlined in our enclosed Financial Statements. In 2023, we recognized an operating surplus for a second consecutive year.

The Colonello Foundation was again a major contributor to our junior development programs in 2023 surpassing over \$300,000 in support since 2019. These resources have a significant impact in helping to grow junior golf in Manitoba and Northwest Ontario.

I would like to acknowledge our team of volunteer photographers who have done an incredible job capturing the 2023 season. It is their photos that help to tell the story of our golf year and that you will see in this report.

To all our corporate, industry and sport partners, I offer my sincere thanks for your commitment to amateur golf and our association. Your support provides critical resources that help to promote and grow the sport of golf across our region.

Last, but certainly not least, I want to thank our wonderful team of volunteers. You helped to make 2023 the successful year that it was.





# HANDICAP & COURSE RATING

The Course Rating Committee and its volunteers rated 10 courses this year and completed a total of 59 tees rated. In addition, we worked with Golf Ontario in rating 5 courses in Northwest Ontario for our ladies' members in that part of the country. To maintain valid course and slope ratings, golf courses are required to be re-rated at least every 10 years or when significant changes are made.

Courses rated this year included Steinbach Fly in Golf Club, Boissevain Golf Course, Poplar Ridge Golf Course in Onanole, Maplewood Golf Club in St. Pierre-Jolys, Southport Golf Club in Portage la Prairie, St. Boniface Golf Club, Virden Wellview Golf Club, Oak Island Golf Course, Elmhurst Golf and Country Club and Breezy Bend Golf and Country Club. Ladies' clubs rated in North West Ontario included Manitouwadge Golf Club, Aguasabon Golf Club in Terrace Bay, and Strathcona, Chapples and Emerald Green in Thunder Bay. Also, we provided ratings for updated combo tees at a number of clubs.

We had a training session in May 2023 to bring all the raters up to date on current developments

The World Handicap System was implemented in 2020 and we are expecting to see some changes to the rules in summer of 2024. We encourage all clubs to participate as the license agreement with the USGA requires that each club have at least one representative certified. These representatives will then be used as a resource for inquiries at the club level. If your club has not sent an individual, please do so and if you have already sent someone, we would encourage you to send others to be educated on the details of the handicap system. We would also encourage clubs to organize seminars specifically for your members and Golf Manitoba will come to your club to assist.

Thank you to all our rating volunteers for their efforts throughout the year. We are looking forward to another busy summer next year for our rating teams as well as continuing to educate Manitoba and Northwest Ontario golfers on the parameters of the handicap system.

We added 2 new raters at the end of this rating year, so are looking forward to their participation in 2024. We continue to look for more people that would be interested in joining our rating team.

## **MEMBERSHIP**

Sue Wright-Cassan

In 2023, golf continues as a safe and expanding activity and we continue to grow the game and increase our number of golfers playing. Golf is a game of experiences. The golf course can be a place of mental and physical health, a destination to bring friends and family together. As much as anything, golf is about community.

Total individual membership increased by 3.1% over 2022 for a total of 10,051. The last time we had over 10,000 members was in 2014.

Six new clubs joined Golf Manitoba in 2023: Boissevain Golf Club, Gladstone Golf & Country Club, Maplewood Golf Club, Marvellous Meadows Golf Course, Russell Golf Club and Winnipegosis Golf Course. We want to thank them for joining us and extend a warm welcome to our golf family!

For the year we had 87 member clubs and leagues (see page 28 for the 2023 directory of our member clubs and leagues).

From a golf services perspective, 2023 has been quite positive. Golf Canada will eclipse a record of 10 million rounds posted to the Score Centre in 2023. Here in Manitoba, that trend continued with over 282,000 rounds posted, a new record for Golf Manitoba. Score posting is still much higher over the past three years averaging 254k rounds per year since 2020. Members are continuing to use the Golf Canada App with over 138k rounds posted in 2023 representing over 49% of all scores posted by Golf Manitoba members.

We are also focused on engaging with public players and facilities and delivering robust tools and services that enhance the value proposition of our membership. Our Public Player membership has grown by 43% from 706 in 2022 to 1,010 in 2023.

The incident protection program also yielded 18 claims in Manitoba paying back \$18,95 to members for equipment, window and travel accident protection.

Not only is an Official Handicap Index a requirement to play in many provincial, national and club events, it makes the game of golf more enjoyable by enabling golfers of differing abilities to compete on an equitable basis.

New for 2023 was the introduction of the National Golf League (NGL). The NGL is a nationwide, season-long competition created by Golf Canada to enhance the league experience for our member golfers. Southwood Golf & Country Club was the host of this year's regional final with three teams qualifing for the national final to be played during the week of the 2024 RBC Canadian Open. Congratulations to the teams of Josh Blatt & Curtis Markusson (St.


Charles Country Club), Nicolas Hince & Brett Charette (St. Boniface Golf Club) and Beniot Mowbray & Daniel Beaupre (Glen Lea Golf Club) and best of luck in next year's final!

We were also pleased to issue 104 Hole-in-One certificates to those members who made their "Shot of a Lifetime" this season. Congratulations on this exciting golfing accomplishment!

As we move into 2024, efforts will remain focused on educating both our member and non-member clubs about the benefits of a membership. As a Provincial Association, Golf Manitoba provides support for golf services, invests in grassroots programs, develops more athletes from a position of strength and drive and deepens junior golf programming to get more kids involved in the sport.

We also assisted the PGA Tour Canada stop by officiating at the Centerport Canada Rail Park Manitoba Open Monday Qualifier. And finally, we were also asked to help officiate the Golf Canada National Golfers League Regional Final at Southwood Golf & Country Club.

This year David Borowski took over as Director of Competition and Rules. He also welcomed two new interns, Emilee Melnyk and Nate Hunter. This should have led to some learning curve problems, but they proved to be a great team and the curve was flattened quickly. Dave is well on his way to becoming a qualified referee, which will be a great asset to the Officials team as it will limit the need for the course referees to cover the scoring and starting areas.

As usual Amy Coggan did a bang-up job of scoring and Jared Ladobruk, our intrepid leader, showed up at every event to help with the presentations.

For a second straight year, Don MacDonald was called to officiate at the USGA Senior Open Championship that was held June 29 to July 2 in Stevens Point, Wisconsin, U.S.A. Congratulations, Don, on your appointment again this year and on his tremendous accomplishment.

This is my last official report to the Annual General Meeting. I have spent 10 years on the Board of Directors and those spent as Chairman of the Officials Committee have been a real pleasure. The elders of the group provided great guidance and without their help I would not have been able to do the job.

It has been my pleasure to serve our golf community the past 10 years and I look forward to another season of refereeing in 2024.

#### **Golf in Schools**

This year Golf Manitoba was pleased to partner with the First Tee - Prairies in our Golf in Schools programming in 2023. Thirty-three clinics were held at 19 school locations in Greater Winnipeg and 14 school locations beyond the Perimeter Highway (4 in the East Region, 3 in the West Region, and 6 in the South Region). A total of 6,251 students participated – 3,154 girls and 3,097 boys.

#### **Junior Mobile Clinics**

During the months of July and August, 11 mobile Clinics were conducted, 9 in Rural Manitoba/ Northwest Ontario and 2 clinics were conducted in Greater Winnipeg. This program was also provided in partnership with the First Tee - Prairies where 391 participants attended the camps,142 girls and 249 boys.

#### Junior Skills Challenge

The 2023 Provincial Skills Challenge was held at the Southwood Golf & Country Club on July 16. 53 competitors participated in three different age categories for both girls and boys: 8 years and under, 9-11 years, 12-14 years. Many of these young golfers competed for their first time.

After competing locally two athletes moved on to the National Junior Skills Competition on August 20/23 at the Shaughnessy Golf and Country Club in Vancouver BC. Sadie Blazeiko (Development Blue team member) placed 1st overall in her age group and Carson Chapman placed 2nd overall in his age group.

#### **Golf Manitoba Student Interns**

Each golf season Golf Manitoba advertises for, interviews, selects, and trains two University students to conduct the above outlined programs. This year our two interns, Emilee Melnyk and Nate Hunter, began their internships in late April and completed their duties at the end of August. They worked cooperatively with the First Tee – Prairies Organization.

#### **Team Manitoba**

Twenty young athletes were named to the Team Manitoba Junior Boys roster under Head Coach, Sean Murray. This roster was divided into two divisions: the Gold team consisting of 12 elite level golfers (7 Winnipeg Club players, 3 public course players and 2 rural club players) and the Blue team consisting of 8 players, 13 years of age and under, (3 club Winnipeg club players, 2 public course players and 3 unaffiliated players). This division is based on the belief that Gold Team players are our elite level golfers who will represent us in the Mundie putter competitions and receive weekly coaching

throughout the year. The Blue team players are an Under 13 age group who received monthly coaching. By having players from 5-8 years in preparation for the Gold Team membership, younger players will be more ready and better prepared for elite competition when they reach the 16-18 age group.

Both teams trained off-season indoors on topics such as fitness, sport psychology, club selection and this year had the added benefit of using the new indoor golf Performance Centre at Sport Manitoba. Once the warm weather arrived added training moved to the out of doors with our Spring Camp on April 29/30 and Mundie Putter season on May 1st . This year our Team competed in the 'A' division of the Mundie Putter league thereby competing against some of the best Club players in Greater Winnipeg and gaining valuable competition experience.

Team members played in numerous club, Provincial, and National tournaments. Some notable results:

- Three Gold Team graduates, Grady Chuback, Kaleb Lambert and Jacob Taweel will continue on to play College golf at the University of their choice.

This year under Head Coach Bri-ann Tokariwski, Team Manitoba consisted of 12 players divided in two sections, the Gold team consisting of 7 players aged 16-17 and the most tournament ready (3 Winnipeg club players and 4 club players outside greater Winnipeg) and 2) the Black team consisting of 5 players aged 13-16 consisting of younger players showing great potential, (3 players

from Winnipeg Clubs and 3 players from locations outside Greater Winnipeg). Coach Tokariwski also carried a third, Blue team of 5 younger players, ages 10-13 who aspire to be future tournament competitors.

The team members spent the spring period working on such topics as sport psychology, nutrition, and fitness (grip strength, endurance, stamina). All team members worked regularly in the new indoor golf performance centre at Sport Manitoba. With the coming of summer, the Teams moved to outdoor training in preparation for the tournament season.

The Team participated again in the B section of the woman's Greater Winnipeg Nassau league, with great success, making the play-offs.

Team members played in numerous club, Provincial, and National events. Some notable results:

We held 16 events and 2 qualifiers in 2023. With the exception of the Match Play qualifier, all tournaments were held without any weather disruptions or delays.

We had a total of 1,743 competitive rounds with 945 participants, compared to 2022 when we had 1,695 rounds and 864 participants. Congratultions to all our 2023 champions as well those who qualified to represent Manitoba in interprovincial competitions at Golf Canada national events.

Once again Junior event entry fees were reduced by 50% in 2023. A total of \$15,000 was made available to juniors who qualified for National level competition to assist with travel costs. Both of these supports were again made possible by the generous commitment of the Alex & Peggy Colonello Foundation that continues to work with Golf Manitoba to support the development of junior golf in the province.

## REPORT OF THE

## TREASURER

Golf Manitoba strikes an operating budget each year using best estimates for the delivery of its programs and services within projected revenue limits. The Executive Director, along with the Golf Manitoba team and with oversight from the Finance Committee and the Board of Directors, manages the operations guided by the budget adopted.

#### **Excess of Revenue over Expenses**

For fiscal year ended March 31, 2023, the Board of Directors had budgeted for an excess of Expenses over Revenue of \$ 4,380.

The accompanying audited financial statements of Golf Manitoba Inc. for the year ended March 31, 2023 report an excess of Revenue over Expenses of \$40,230 as compared to the previous year ended March 31, 2022 wherein there was an excess of Revenue over Expenses of \$139,729.

The prior year results included \$80,881 in government funding related to the pandemic, which was not matched in 2023. The net results in 2022 would have been more comparable to the current year without that funding

#### **Revenues - Issues of Note**

Revenues from operations for the year (excluding the subsidies and grants discussed above) were \$40,747 more than in the prior year. The significant differences were in the following areas:

Description	2023	2022
Sponsorship	\$173,280	\$143,873
Membership Dues	\$193,022	\$166,122

- · Sponsorship change Larger contribution from the Colonello Foundation and additional sponsors during the year
- Membership change Golf Manitoba/Canada membership dues were increased in 2023, clubs saw increased member registration, and casual golfers continued to find the game as they became more comfortable interacting with others. Additional facilities joined and we say another consecutive year of increased public player members.

## **Expenses - Issues of Note**

Overall expenses from operations for the year were also up to the tune of \$42,928 more than in the previous fiscal year. The largest differences were in the following areas:

- · Wages were re-allocated to different categories with programs being able to be held again
- Tournament expenses went up due to all tournaments being held and over-budget attendance,

A small Excess of Revenue over Expenses has been budgeted for the 2023-2024 fiscal year.

At this time I would like to thanks Jared and Amy and the Finance Committee for all their assistance and diligence in looking after the finances for Golf Manitoba this past year.

# GOLF MANITOBA SCHOLARSHIP FUND

The Golf Manitoba Scholarship Fund's mandate is to provide scholarships to student golfers for the advancement of their education at a Canadian post-secondary educational institution through the receipt, investment, accumulation, and disbursement of funds for that purpose. Scholarships are awarded to golfers who submit applications which meet established criteria for academic achievement, community involvement and golfing ability. Since 1986, the Scholarship Fund has awarded over 200 scholarships, totaling more than \$230,000 to student golfers throughout Manitoba and Northwestern Ontario.

In 2018, the Scholarship Fund transitioned over to The Winnipeg Foundation. The completion of assets occurred in late 2022. The Scholarship Fund has already benefited significantly from this process in the form of matching funds and increasing yield on the financial assets held with The Winnipeg Foundation. This has allowed for an increased number and value of scholarships being able to be awarded -- in 2023, 11 scholarships totalling \$17,500 were available for disbursement.

The Scholarship Fund has a number of scholarships named in honour of individuals that have specific criteria. In addition, there are several Golf Manitoba general awards available:

- The **Dr. Dwight Parkinson Scholarship** is awarded to the secondary school graduate with the highest academic achievement who will be pursuing a post-secondary education. The scholarship was established on a perpetual basis from a generous donation received from Mr. David Hill.
- The **Brian Gilhuly Memorial Award** is presented to a candidate demonstrating superior scholastic achievement who is continuing their academic career. This scholarship was funded on a perpetual basis due to a generous endowment from Brian Gilhuly's estate.
- The Craig Yahiro Memorial Scholarship is two awards, one to a woman and one to a man, who are entering or continuing with post-secondary studies and who are either Golf Manitoba members or who are currently involved with golf either through employment or participation. This scholarship is funded through the generosity of the Yahiro Family and an annual fundraising event held at Rossmere Country Club.





Dennis Langrell (1954-2021) was posthumously honored as the 18th recipient of the Golf Manitoba Distinguished Service Award.

Dennis volunteered with Golf Manitoba for over 28 years. He served in various compacities including player development, officiating and most recently as the president of the Golf Manitoba Scholarship Fund until his passing in April of 2021.

Dennis was an instrumental contributor to the junior golf development program with Golf Manitoba. He assisted in managing the association's junior boy's Mundie Putter team, assisted at numerous junior golf camps and acted as non-playing captain for Golf Manitoba at the Canadian Junior and Western Canadian Juvenile Championships.


## **RHONDA ORR & BRAXTON KUNTZ**

On behalf of selection committee members Clayton Dreger, Jill Hardy, Adam Speirs and Ken Wiebe, Golf Manitoba is pleased to recognize the 2022 Female and Male Amateur Golfer of the Year Award winners.

The 2022 recipients were announced at the annual Golf Manitoba Awards reception that was held at the Breezy Bend Country Club on November 2.

Rhonda Orr of Southwood Golf & Country Club is the Female Amateur Golfer of the Year.

Orr, 61, from Winnipeg, won the Mid-Amateur Flight and finished second overall at the Diamond Athletic Women's Amateur Championship. She represented Team Manitoba at the Canadian Women's Amateur. The Southwood Golf and Country Club member won the Hodson Financial Women's Senior Championship, her seventh senior provincial championship in a row and ninth in the last ten years. Orr went on to finish 10th on the leaderboard playing for Team Manitoba at the Canadian Women's Senior Championship. Orr also tied for eighth place at the AGA Women's Senior Amateur Championship in the United



States.

With the selection, it is the fourth time that Orr has been recognized as Female Amateur Golfer of the Year (2016, 2018, 2019).

Braxton Kuntz of Breezy Bend Country Club is the Male Amateur Golfer of the Year.

Kuntz, 18, from Winnipeg, won the Manitoba Junior Championship presented by the Alex & Peggy Colonello Foundation and represented Team Manitoba finishing in a tie for fifth place at the Canadian Junior Boys Championship. The Breezy Bend member also won the Nott Autocorp Men's Amateur Championship. Kuntz is the first player in Manitoba to win both the Manitoba Junior and Amateur Championship in back to back seasons (2021 and 2022). He also finished tied for third place at the Elmhurst Invitational.

With the selection, it is the second time in as many years that Kuntz has been named Male Amateur Golfer of the Year (2021).

About the Golf Manitoba Amateur Golfer of the Year Award – The Manitoba Amateur Golfer of the Year award recognizes outstanding performance by Manitoba golfers in all levels of competition with the first award presented in 1975. In 2015, the award was re-established to include both a female and male category.

#### Opinion

### Notes to Financial Statements Year Ended March 31, 2023

#### DESCRIPTION OF ORGANIZATION

Golf Manitoba Inc. (the "organization") is a non-profit organization established to develop, promote, govern and service the game of golf in Manitoba and North West Ontario for the benefit of all participants.

The organization is exempt from taxation as a non-profit entity under Section 149(1) of the Income Tax Act.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations. Because a precise determination of many assets and liabilities is dependent upon future events, the preparation of financial statements for a period necessarily involves the use of estimates which have been made using careful judgement. The financial statements have, in management's opinion, been properly prepared within the reasonable limits of materiality and within the framework of the significant accounting policies summarized below:

#### Financial instruments

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

#### Investments

Investments, which consist of guaranteed investment certificates with original maturities at date of purchase beyond three months, are carried at amortized cost.

#### Inventory

Inventory is recorded at cost and consists of rule books, pins and clothing.

#### Capital assets

Capital assets are stated at cost or deemed cost less accumulated amortization. Capital assets are amortized over their estimated useful lives on a straight-line basis at the following rates:

Computer software	4 years
Golf Studio	4 years
Office equipment	3 to 5 years
Office furniture	2 to 4 years
Tournament equipment	3 to 5 years

The organization regularly reviews its capital assets to eliminate obsolete items.

### Deferred capital contributions

Deferred capital contributions represent contributions received which are restricted for the purchase of capital assets. The deferred amounts are recognized into revenue at the same rate of amortization as the related acquired capital assets.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

### Revenue recognition

The organization follows the deferral method of accounting for contributions. Externally restricted contributions are recognized as revenue in the year in which the related expenses are recognized. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

#### Donated services

A large number of volunteers donate significant amounts of their time to program events and fundraising activities. No amount has been reflected in the financial statements for donated services since an objective basis is not available to measure the value of such services.

#### Allocation of salaries and wages and office expenses

The organization allocates salary and wage, and office expenses to three functional areas: administration, program management and tournament. The percentages are based upon estimates of staff time and resources spent for each area. These percentages are reviewed every year to determine whether there has been any significant shift which might warrant a change to the allocations.

#### 3. FINANCIAL INSTRUMENTS

The organization is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the organization's risk exposure and concentration as of March 31, 2023.

#### Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The organization is exposed to credit risk from funders, members and users. Due to the nature of the organization and its history with contributors, management assesses the credit risk as low.

#### 5. LINE OF CREDIT

The organization has a \$10,000 line of credit with the Assiniboine Credit Union bearing interest at prime plus 1% and is secured by a general security agreement providing a fixed charge over all assets. The organization has not utilized the line of credit as at March 31, 2023.

#### 6. DEFERRED CAPITAL CONTRIBUTIONS

Deferred capital contributions represent grants received from Sport Manitoba that have been deferred for the purchase of capital assets. The deferred capital contributions will be recognized into revenue over the life of the capital assets, once these capital assets are in use.

### 7. INTERNALLY RESTRICTED

Net assets in the amount of \$100,000 had been internally restricted by the Board of Directors for future capital acquisitions.

The \$100,000 for future capital acquisitions remains in the fund at March 31, 2023.

Future appropriations will be made, of funds considered surplus to ongoing operations, on an annual basis upon approval by the Board of Directors.

Assets have not been specifically designated and set aside for the purposes of funding this internal restriction of net assets.

#### 8. NON-CONSOLIDATION OF CONTROLLED ENTITY

At November 30, 2022, the organization is the sole member of the Manitoba Golf Scholarship Fund Inc. (the "Fund"). The purpose of the Fund is to provide financial assistance to young golfers for the purpose of enabling them to further their education at a Canadian post-secondary educational institution. The Fund is incorporated under the Corporations Act of Manitoba and is a registered charity under the Income Tax Act. The Fund has not been consolidated in the organization's financial statements. The financial summary of the Fund as at November 30, 2022 and for the year then ended is as follows:

During the year ended November 30, 2022, the Manitoba Golf Scholarship Fund Inc. made a \$31,061 (2021 - \$37,664) contribution to the Winnipeg Foundation Endowment Fund. At March 31, 2023, the market value of the contributions made to the Winnipeg Foundation was \$381,108. Any future income earned from this endowment fund will be recorded as revenue by the Manitoba Golf Scholarship Fund Inc. in the year that it occurs.

### 9. SIGNIFICANT INFLUENCE

The organization exercises significant influence over the Manitoba Golf Hall of Fame and Museum Inc. (the "Hall of Fame") by virtue of its ability to appoint 4 of the 13 Hall of Fame's Board of Directors. The Hall of Fame was established to raise funds to acknowledge the contributions and accomplishments of Manitobans to the game of golf. The Hall of Fame is incorporated as a corporation without share capital under the laws of Manitoba and is a registered charity under the Income Tax Act. Net assets of the Hall of Fame amount to \$6,520 at November 30, 2022 (2021 - \$7,640).

#### 10. COLONELLO FOUNDATION

Beginning in the 2020 fiscal year, Golf Manitoba received new sponsorship from the Colonello Foundation. The Colonello Foundation has pledged funding to Golf Manitoba in support of developing new generations of golfers through grassroots golf initiatives and high-performance programming.

This sponsorship has also led to increases in Golf Manitoba's Teams and Public Relations & Sponsorship, and Tournament expenses as the funding from the Colonello Foundation has been used to fund golf programs throughout the province and assist junior teams with their expenses.

Golf Manitoba expects to continue their relationship with the Colonello Foundation for the foreseeable future.

#### 11. RELATED PARTY TRANSACTIONS

Included in the organization's program management expenses are operating grants of \$1,000 to the Manitoba Golf Hall of Fame and Museum Inc. which is related as described in Note 9.

#### 12. NON-MONETARY TRANSACTIONS

The organization has an agreement with Nott Autocorp which allows them to use a vehicle for 5 months from Nott Autocorp. The financial statements include the full market cost for the use of the vehicle and the difference is recorded as sponsorship revenue.

The organization has a sponsorship agreement with TaylorMade which provided the organization with golf balls, hats and golf bags. The financial statements include the fair market value of the products received and the fair market value of the cost for products given out to players.

The organization has a sponsorship agreement with Adidas Canada Limited which provided the organization with golf apparel. The financial statements include the full fair market value of the products received.

#### 13. PENSION PLAN

The organization maintains a defined contribution pension plan for most of its employees. All contributions are fully funded on a monthly basis and are included in wages and benefits expense. During the year \$9,156 (2022 - \$8,519) was recorded as an expense in relation to this pension plan.

#### 14. CANADA EMERGENCY BUSINESS ACCOUNT LOAN

The Canada Emergency Business Account (CEBA) provides interest-free loans of up to \$60,000 to small businesses to help cover their operating costs during a period where their revenues have been temporarily reduced. This program has been implemented by banks and credit unions in collaboration with Export Development Canada.

Repaying the balance of the loan on or before December 31, 2023, could result in loan forgiveness of 25 percent (up to \$20,000). During the 2023 fiscal year, the loan was repaid in full.

### 15. CONTINGENT LIABILITY

The organization currently has a claim that been filed against them by a former employee. At audit report date, the amount of the settlement is unknown. However, its likely the organization and former employee will settle for an amount between six to fifteen months of compensation. The former employee has been on salary continuance since January 2023. Included in accounts payable and accrued liabilities is \$17,448 relating to this amount to bring the expense up to six months of compensation potentially owing. No amounts related to the additional nine months potentially owing has been recorded.
